## ***Thank you for being part of Aumsville's 2020 "2<sup>nd</sup>-Saturday Market!"***

Here are some guidelines that will help make everything run smoothly:

**Set up** begins at 7am and we ask that you have your booth setup and all vehicles removed by 8:30am (see vendor parking below). Doors open to the public at 9:00 AM but sometimes people will wander through early.

**Space Location:** Please check in with the event coordinators as soon as you arrive, and they will let you know where your assigned spot is located. They are usually walking around with a clipboard in hand.

**Vendor Parking and Set-up:** (The following guidelines are meant to keep the market area uncongested and safe for pedestrians)

- You may unload your vehicles from the paved parking area adjacent to the market area.
- Unload your product and move your vehicle to the vendor parking area in the grass field east of the market
- Vendor parking is accessed off of 11<sup>th</sup> Street.
- Then come back and set up your booth after you have moved your vehicle
- No Vendor parking in the paved parking next to market area after 8:30am.

### **No Early Teardown:**

- **No tear down before 3 pm.**
- **Vehicles will not be allowed into the paved parking area to load until 3:01pm.**
- **We have advertised that booths will be open until 3pm and need to make sure that we honor that.**
